### About the safety training program

LOC-I is one of the leading causes of fatal accidents and passenger fatalities in the aviation industry.

UPRT is the only program of its kind available within the aviation industry that promotes comprehensive and integrated upset prevention and recovery training through credit incentives. The goal of this program is to elevate aviation safety through advanced pilot training. By embedding financial incentives to complete advanced training into the insurance purchase, clients can access and implement practical risk management and threat mitigation strategies.

This program delivers the most comprehensive web-based academic, in-flight, and full-flight simulator training designed to teach aviation professionals how to recognize, avoid and effectively recover from emergency, stalled and unusual attitude situations, as well as enhance overall flying skills to improve safety of flight.

### How it works

#### **What is Loss of Control In-flight?**

Loss of control in-flight (LOC-I) is defined as flight that occurs outside of the normal flight envelope with an inability of the pilot to regain control of the aircraft. LOC-I is one of the leading causes of fatal airplane accidents and passenger fatalities in business and commercial aviation.

LOC-I presents a unique challenge to the aviation industry; it highlights a serious deficiency in a pilot's ability to deal with a variety of unusual flight scenarios and flight envelope excursions. Advanced upset prevention and recovery training (UPRT) provided by APS and CAE is proven to elevate pilot awareness, knowledge and skill in mitigating LOC-I.

Even with advanced avionics and technology, LOC-I situations may arise. Equipment failure, pilot error and environmental factors all contribute to the possible occurrence of an airplane upset that can lead to LOC-I. It is, therefore, critical to enhance pilot awareness and skill through advanced training.

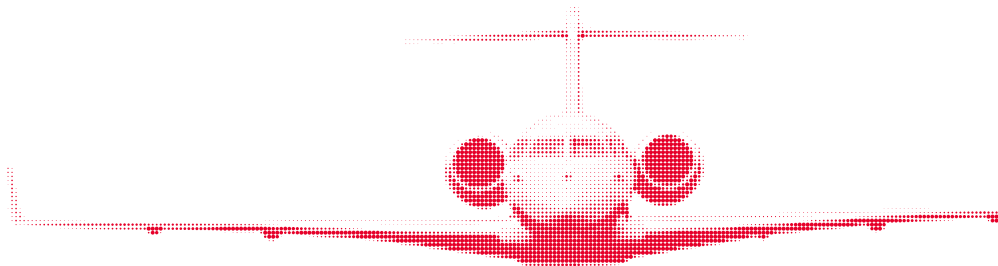
